



Memorandum of Understanding

Between

Norwich Institute for Language Education

and

University of Oran 2 Ahmed Ben Ahmed



This Memorandum of Understanding (MoU) is made on Monday, 13 April 2026 between Norwich Institute for Language Education (NILE) 78-80 Upper St Giles Street Norwich NR2 1LT United Kingdom of the one part and University of Oran 2 Mohamed BEN AHMED, Campus Universitaire Abdelmalek Mortad, Belgaid, BP1015 Mohamed SAIM, Oran (henceforth referred to as UORAN2) of the other part, and together referred to as “the Parties”.

1 The Purpose of the MoU

- I. The Parties wish to affirm the establishment of a special relationship between them with the intention of promoting their common interest in advancing education in general and Higher Education in particular on the basis of friendly cooperation, mutual respect, mutual benefit and mutual enhancement.
- II. In establishing this relationship, the Parties recognise that they share a common interest in exploration and development of learning and teaching, research and scholarship, academic cooperation, and cultural activity.
- III. The Parties agree that by signing of this MoU they do not intend to create any legally binding obligations between them unless expressly stated herein.

2 Range of Activities

The parties will promote links between members of staff with common interests and operate together as appropriate to further general education and cultural interests in their shared academic areas. In particular they will seek to co-operate in the following areas of mutual interest:

- I. Encourage mutual visits and collaboration between the institutions.
- II. Support the professional development of academic and administrative staff for developmental purposes, as determined by the senior administrative staff and academic officers at the respective institutions.
- III. Consider the hosting of cultural events and academic programs from the other institution that may enrich or expand the educational understanding and experience of students and staff.
- IV. Holding training for teachers and staff.

3 Administration of the MoU

- I. The persons responsible for the management of links made under this Memorandum of Understanding for NILE will be Thom Kiddle, Director.

- II. The persons responsible for the management of links made under this Memorandum of Understanding for UORAN2 will be Dr. Ismail AMANI, Vice rector of external relation and cooperation

4 Further Agreement

- I. This Memorandum of Understanding sets out the overall terms agreed between the Parties. However, it is intended that:
 - a. in the event of the development of an agreement to run a programme collaboratively, a specific Memorandum of Agreement will underpin that arrangement;
 - b. each Party will abide by its respective equal opportunity policy in sending and hosting students, faculty, and staff; and
 - c. all financial arrangements necessary to implement any agreement will be negotiated according to the regulations of each Party and depend on the availability of funds.
- II. This Memorandum of Understanding does not in itself entail any financial obligations for either Party.

5 Duration of the MoU

- I. This Memorandum of Understanding is made for a 3-year period from the above date, and is renewable for similar periods, subject to review by each Party and their consent to continue.
- II. This MoU may be terminated in writing by either Party, subject to a period of notice of one month. The notice must be given by the Director / Vice Chancellor (as the case may be) of the Party terminating the MoU to the Director / Vice Chancellor (as the case may be) of the other Party.
- III. In the case of the termination of the MoU the Parties will seek to ensure as far as possible that current activities are completed.

6 Governing Law and Jurisdiction

- I. If this Agreement or any other document related to it is translated into a language other than English, and if the translated version is different from the English language version, the English language version shall take precedence.
